**Documentation Requirement:** Copies of registration papers must be provided with entry documents for NMDA classes. For safety and wellbeing, ALL donkeys will be required to have a current health certificate and proof of a negative equine infectious anemia (Coggins) test at time of check-in and measurement. Check-in, measurements, and document verification will begin Friday afternoon.

**Entry fees:** Youth classes are **FREE**. All other classes are \$15 each donkey per class, unless otherwise specified. **Entries are due no later than May 24, 2025**. Any additional entry received or modified after that date may have additional administrative charge of \$25 per donkey. No refunds for withdrawing from any class/show once the first class begins. Exceptions may be granted with approval of show management and/or the ADA board.

**Administration fees:** There is a \$10.00 per donkey administrative fee which is utilized by the American Donkey Association (ADA). There is a \$2.00 per donkey fee which is paid to The National Miniature Donkey Association (NMDA).

**Camping:** RV sites – 30 amp service - \$40 per night. Limited to 24 sites – first come, first served based on date/time of receipt of entry. Dry camping is free.

**Stalls:** Stalls are \$40 per night. Donkeys remaining on the show grounds overnight, must be placed in stalls. There is a limit of 2 donkeys per stall. Having donkeys in trailers overnight is prohibited. Water is at the stalls. Shavings are not provided, but there are two feed stores within 6 minutes of the arena. You are welcome to arrive beginning Friday, June 6, 2025. You are welcome to stay through Monday, June 9, 2025. If you require additional time, you can contact Triple Crown Equestrian Center. Stalls must be completely cleaned prior to your departure. Failure to remove all bedding and/or extra feed may result in an additional charge of \$50 per stall billable to person assigned to that stall.

**Day Use:** If you are coming in for the day only, and not requiring a stall, there is a \$10 per day, 'trailer in' fee.

**Feed Stores:** Feed stores nearest the arena include Sierra Hay & Feed, 1301 Lincoln Blvd, Lincoln CA 95648 – (916) 645-3638; Superior Livestock Supply, 641 H St, Lincoln CA 95649 – (916) 434-8174

**Payback:** Payback will be provided on classes having **5 or more entries:**  
1<sup>st</sup> - \$15, 2<sup>nd</sup> - \$10, 3<sup>rd</sup> – \$5

### **Points Reporting:**

This is an NMDA sanctioned show. NMDA Class results will be reported to NMDA within 15 days of conclusion of show. You must be a paid member of NMDA for your donkey to be eligible for NMDA awards. There is a \$2.00 per donkey per show fee.

- No campfires are allowed anywhere on the grounds.

- Sale of alcohol is not permitted. Alcohol consumption during youth activities is prohibited.
- Firearms, explosives, or articles deemed hazardous due to flammability are prohibited.
